Dimensions, weights, lifting points/lugs and center of gravity to be clearly indicated allowing for the carrier to lift the cargo in equilibrium. Shipper/Merchant responsible for cargo insurance. All cargoes are subject to final transport drawings, technical details and Master's and Carrier's port captain's approval of stowage. Any special slings and/or spreader bars and/or shackles required to lift the cargo including any special saddles and/or cradles required to support the cargo to be supplied by the merchant at merchant's time risk and expense. Any dues, taxes, duties on cargo and/or calculated on freight including local THC and Wharfage for Merchant's account both ends.</p> <p>Vessels to be substituted at liner's option without notice. An additional charge of US\$ 75.00 will be assessed each time a Bill of Lading must be re-issued. Any self propelled vehicle that is unable to be driven when delivered to the terminal or under hook will be assessed the stevedoring/terminal charges required to move the unit accordingly.
