Minimum charge for any delivery or pickup is **\$55.00**.

Crane, if required, **\$450.00 per hour**, 2 hour minimum.

Top loader, if required, **\$192.50 per hour**, 2 hour minimum.

Cargo requiring special handling or crane is a single piece of cargo which:

- a. exceeds 50,000 lbs
- b. due to shape, oversized dimensions, nature, packing cannot be handled safely with a single forklift
- c. can only be handled by overhead lifting
- d. is described as such by shipper or receiver and for which special handling procedure has been received by the terminal. Please contact Coastal Cargo of Texas, Inc. to make an appointment.

*Any cargo 100,000 lbs or over may require specialized equipment and / or cranes to move the cargo from POR to under ship's hook. These costs are in addition to regular THC/Receiving Rates and to be for merchant's account and will be determined on a case by case basis.

Minimum Wharfage is **\$10.00**.

All cargo subject to Port of Houston Security Charge of **\$ 0.19* per 2000 lbs**. Container Fee is **\$3.63 per container** and vehicles are **\$ 1.04 per unit**.

Free Time on containers as per Port of Houston Tariff – 3 business days

*NOTE: Port of Houston has increased the Port Security Fee for breakbulk effective 1 January 2018.
